Inhalation	Remove victim to fresh air away from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Occupational Release	Minor spills do not normally need any special clean-up measures. In the event of a major spill, prevent spillage from entering drains or water courses. Wear appropriate protective equipment as in section 8 below to prevent skin and eye contamination.
